# 5. LANGUAGE OF INSTRUCTION

ISCAL provides courses taught in Portuguese and English.

Foreign students are advised to choose and enroll in courses from those available in English. However students can take part in courses different from those. One should, however, be aware that these are fully taught in Portuguese and the evaluation conducted also in Portuguese.

# 6. ACCOMMODATION

The search for accommodation is the responsibility of foreign students. The International Relations Office of ISCAL might assist foreign students in this task by providing them with a list of recommended contacts. Any other measures must be ensured by the students themselves.



# 7. HEALTH INSURANCE

Erasmus students are required to have a valid European Health Card issued at their home country (the EHC should be valid during the whole period of mobility). Non-EU students are required to have commercial health insurance which covers medical expenses for the insured in case of accidents.

# 8. VISA

There are no visa requirements for EU citizens. Non-EU citizens, citizens from countries outside the Schengen Area or from third countries should apply for a residence permit on arrival.

#### 9. GRADING SYSTEM

In Portugal the higher education grading system ranges from 0 (zero) to 20 (twenty), 0 (zero) being the lowest and 20 (twenty) the highest score.

A full term is awarded a total of 30 ECTS and a whole academic year is awarded a total of 60 ECTS.

### **10.** INDIVIDUALS WITH MOBILITY OR OTHER DISABILITIES

ISCAL's premises are fully accessible to individuals with mobility disabilities including wheelchair access, wheelchair lift, and toilets with wheelchair access.

The lecturers may also provide special assistance during lessons and exams to students with mobility or other disabilities. Special conditions do also apply to students with mobility or other disabilities as far as evaluation is regarded. These may include a longer period of time to take the exam or specific informatics hardware and software, depending on the disability of the student.

### 11. PORTUGUESE LANGUAGE COURSES FOR FOREIGN STUDENTS

ISCAL offers a specific subject of Portuguese for Foreign Students to all foreign students studying at the school in winter and summer terms. This course is included in the list of courses offered to foreign students at ISCAL and is awarded 5 ECTS.
